Angela Snyder presented Ordinance for appropriations and tax rates for the 2021 budget. General adopted budget \$144,783; LIT \$8,800; LRS \$80,000; MVH \$61,400; Cemetery \$21,050 CCI \$2,000; EDIT \$29,750; Sanitation \$26,000; Water \$73,340; Home- rules funds \$8,800. Randy Drake Motioned to accept budget as is. Daniel Davidhizar seconds the motion. All ayes we cast.

Joshua Chapman from Triad Associates, INC, presented the mapping to replace old water lines listed that have not been changed. Triad would like the lines to be bored to identify what the lines are made of if they are pvc or transit.

Randy Drake would like to get with Kory Ferguson to get the prices to purchase the necessities for the INDOT Water replacement and Water Drain issue areas before the project begins.

Daniel Davidhizar presented we need to schedule leaf cleanup for this next month.

Daniel Davidhizar has looked up the prices for the volleyball court its around \$156 dollars for the complete project. Angela Snyder presented the Fund Report. Daniel Davidhizar motioned to approve bank reconciliation. Randy Drake second the motion. All ayes cast.


Randy Drake would like to schedule a Executive meeting on November 3rd at 6pm.
